

Virtual TTT Program for In-Person Delivery





The ELI **Train the Trainer (TTT) Program** for in-person, facilitator-led delivery is a general certification that prepares Human Resources, EEO, L&D, or other professionals to teach the in-person, instructor-led versions of ELI's Civil Treatment Workplace learning solutions. This certification is delivered via two virtual sessions per day over three consecutive days for a total instruction time of 16.5 hours. Participants are assigned pre-work that takes approximately 2-4 hours to complete before the program and offline activities during the certification that require no more than one hour of additional time.

This experience will focus on developing facilitators who can teach one of the following ELI learning solutions in an in-person, live learning experience:

OBJECTIVES FOR THE VIRTUAL CLASSROOM CERTIFICATION PROCESS During the ELI TTT Program, candidates will:

- Explain the business importance of maintaining a professional, inclusive workplace.
- Model ELI's learning philosophy and instructional methodologies to create an interactive, engaging learning experience that inspires changes in behavior.
- Explore methods for integrating values, policies, and other standards to personalize the learning experience.
- Demonstrate effective facilitation competencies.
- Explore issues of conceptual resistance and techniques for addressing challenging classroom behaviors.
- Explore implementation and sustainability tools.

CERTIFICATION PRE-WORK:

Before logging on to the certification, participants will:

- Read about ELI's Learning Philosophy, Methodologies, and Certification Criteria.
- Prepare two teach-backs to practice facilitating portions of an ELI learning solution.

*Prework is estimated to take between 2-4 hours and must be completed before Day 1 of the certification program.
